## GUIDELINES AND REVIEW PAPER COVID-19

The Polish Ophthalmological Society of presents recommendations on the use of contact lenses during the COVID-19 epidemic.

Kropacz-Sobkowiak and Michalski analyzed methods of protection against SARS-CoV-2 virus infection in the contact lens fitting room and strategies for preparing for the time after the epidemic in Poland.

## ORIGINAL PAPERS Cataract

Podborczyńska-Jodko *et al.* assessed visual function after cataract surgery with mixed implantation of AcrySof IQ ReSTOR lenses (addition to near vision in the dominant eye +2.5 D, in the contralateral eye +3.0 D).

## Intraocular pressure

Nowak *et al.* assessed changes of intraocular pressure (IOP) associated with physical exertion. The study group were healthy participants of the 500 km relay race.

## Hygiene of visual work

Skoblina *et al.* evaluated the awareness of the negative impact of excessive

use of electronic devices by schoolchildren and students.

## CASE REPORTS

Post *et al.* described the treatment process of a 37-year-old man hospitalized for open angle glaucoma accompanied by chronic edema of the optic disc resulting from the presence of optic sheath meningioma.

Linke *et al.* presented the case of a 59-year-old female patient with sporadic form of Creutzfeldt-Jakob disease in the Heidenhain variant.

Pelińska *et al.* presented the results of binocular Yokoyama procedure with a simultaneous recession of recti medialis muscles in a 63-year-old patient with high myopia.

## VARIA

At the beginning of 2020, the textbook "Praktyczna okulistyka dziecięca" (Practical Pediatric Ophthalmology) by Assoc. Prof. Anna Gotz-Więckowska, MD, PhD, and Marta Pawlak, MD, PhD was published. Assoc. Prof. Wojciech Hautz presented his assessment of this needful educational book.

Professor Robert Rejdak prepared a review of the English-language book "Current Concepts in Ophthalmology" edited by Prof. Andrzej Grzybowski.
